

Cloning a certificate will create an **exact copy of a certificate you previously issued**. This method will copy everything from the Named Insured to the policies, holder, and endorsements.

What is the benefit in using the Clone method to issue a certificate?

If you have an Insured that repeatedly submits identical certificates requests, with perhaps only one small difference between requests, (for instance, the project number in the Description of Operations, or the Holder Name), certificate cloning might be the best processing method for you.


Because a cloned certificate is an exact replica of a historically issued certificate that was previously approved by all parties (Holder, Insured, Etc.), you'll know the cloned certificate will already meet the requirements by the same parties.

Certificate cloning lets you issue a certificate with the **utmost efficiency**, saving you **valuable time** because you were able to **make use of work you did before**.

This guide will review selecting the most common ACORD form, the ACORD 25.

How to Clone a Certificate

To begin, drop down "Certificates" and click "Manager".




Within your certificate manage, find a certificate you want to clone.


You can utilize the "Filters" option to conveniently search through your certificates. Once you found the certificate you want to clone, click the "Actions" menu on the far right.




